CONSIDERATION of being permitted to compete, practice weekdays or weekends, officiate, work, and volunteer or
participate in any way in the Winter Thunder Challenge herein referred to as "WTC" events, EACH OF THE UNDERSIGNED,
regardless of emancipation, for himself/herself, his/hers personal representatives, heirs and or next of kin, agrees to and will:

1. HEREBY RELEASES, WAIVES, DISCHARGES, AND CONVANTS NOT TO SUE the promoters, individual board of directors their families, participants, spectators, contractors, racing organizations, sanctioning organizations or subdivision thereof, track operators, track owners, paid track workers, track or facility volunteers, facility lessee, The Golf Farm, Deacon Kalish personally, property owners or lessee of the premises herein all referred herein to as "releasees" used to conduct the events, premises workers and event inspectors, surveyors, underwriters, consultants and others who give recommendation, directions, advice or instructions or engage in risk evaluation or loss control activities regarding the premises at any event including social activities sanctioned by WTC regardless of location, racing events, practice events, facility set up and take down, FROM ANY AND ALL LIABILITY TO THE UNDERSIGNED, his/her personal representatives, assigns, heirs and next of kin FOR ANY AND ALL LOSS OR DAMAGE AND ANY CLAIM OR DEMANDS THERE FOR ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH, LOSS OF WAGES OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENTS, WHETHER CAUSED BY NEGLIGENCE OF THE RELEASEES OR OTHERWISE..
2. HEREBY AGREES TO HOLD HARMLESS TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees, personally or otherwise and each of them FROM ANY LOSS, LIABILITY, COST, OR LOSS OF WAGES that may incur arising out or related to the UNDERSIGNED'S INJURY, DEATH, LOSS OF WAGES WHETHER CAUSED BY NEGLIGENCE OF THE RELEASEES OR OTHERWISE AT ANY EVENT SANCTIONED BY "WTC" ON PREMISES OR OTHERWISE.
3. HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH, PROPERTY DAMAGE OR LOSS OF WAGES by the releasees or otherwise.
4. HERBY acknowledges that THE ACTIVITIES OF THE EVENTS INCLUDING RACING, PRACTICE AT ANYTIME ARE VERY DANGEROUSE AND INVOLVES THE RISK OF SERIOUS INJURY AND/OR DEATH AND/OR PROPERTY DAMAGE. Each of the undersigned, also expressly acknowledges that injuries received may be compounded or increased by negligent rescue operations or procedures by the releasees.
5. HERBY agrees that this BLANKET RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK & INDEMNITY AGREEMENT FOR THE WINTER THUNDER CHALLENGE, WAUCONDA, ILLINOIS, RACE SEASON. NOT LIMITED TO RACING INCLUDING ANY AND ALL PRACTICES FOR THE CALENDAR YEAR 2008 extends to all acts of negligence, including racing events, any and all practice events, social events not limited to the premises, INCLUDING NEGLIGENT RESCUE OPERATIONS and is intended to be as broad and inclusive as permitted by laws in the State of Illinois in which the activities are conducted and that if any portion thereof is considered or held invalid, it is agreed that the balance shall not withstanding, continue in full legal force and effect.
